- EN 50581:2012 Technical documentation for the assessment of electrical and electronic products with respect to the restriction of hazardous substances. For purposes of this Declaration, “Conform” means that each homogeneous material (as defined by the RoHS Directive) in each of the Products contains no more than:
  - 0.1% by weight of each of the following substances:  
Lead, mercury, hexavalent chromium, polybrominated biphenyls, polybrominated diphenyl ethers, bis(2-ethylhexyl) phthalate, benzyl butyl phthalate, dibutyl phthalate, and diisobutyl phthalate
  - 0.01% by weight of cadmium
- Overland-Tandberg is making use of the exemptions of ANNEX III of Directive 2011/65/EU of the European Parliament and of the Council of 8 June 2011.
